During the open period of the election, the ballots were returned to a post office box in Atlanta, GA and remained in the custody of the United States Post Office until the ballot pickup at 11:00AM on June 20. Kenneth Mostern of MK Elections was present with representatives of the local's Election Committee at the ballot pickup, and retained custody of the ballots until they were brought to the union hall for the count. We counted the ballots at the union hall in Atlanta immediately following the ballot pickup.

During the open period of the election MK Elections tracked the return of undeliverable ballots and mailed replacement ballots to voters upon their request and/or the request of the organization.
